



Order

The voting on the three posts of BCA i.e. (1) President (2) Vice- President (3) Treasurer is scheduled to take place on 05.08.2023. Rules of Procedure for conduct of the above said election has been issued by the Electoral Officer vide his office memo no. 22/BCA Elec. dt 22.07.2023.

AS per clause VI (a) of these "Rules of Procedure" the Electoral Officer shall cause arrangements to be made for voting by the representative of eligible members on the Election Day.

In view and adoption of the same by BCA, it is clarified and ordered that only duly authorized Representative of the office bearers of DCA concerned, as reflected in the "Name of office bearers of full members of Bihar Cricket Association" as published on 22.07.2023 will be allowed to vote for the post of BCA which are going to poll. The voter must also be one of the office bearers of the DCA concerned as reflected in the final Electoral Roll to be published on 24.07.2023 by the Electoral Officer BCA Patna. The authorized representative will come to vote with his original Aadhar card/ Elector Photo Identity Card (EPIC) and Affidavit. The format of the Affidavit is annexed with this notice to ensure that their eligibility to vote conforms with the provisions of the Lodha Committee recommendations.



Instructions regarding Poll Process for BCA By-Election 2023

1. Poll Process will start from 10:00 am on 05.08.2023 at Darbar Hall, Hotel Maurya, South Gandhi Maidan, Patna and it will be concluded with the distribution of the certificates to the winning candidates on the same day. Duration of poll will be from 10:00 am to 02:00 pm. After poll counting will be started.
2. Contesting candidate himself may remain in the space earmarked for them near the Polling Station from where the polling process is visible (But not the actual polling) right from the start of the polling to the end of counting or he may appoint duly authorized one day before a polling agent to remain present in the polling station in the space earmarked for this during the period of poll. However, both cannot remain present at the same time. He may appoint the polling agent as his counting agent also or may appoint some another person as his counting agent for being present during counting but when a counting agent is appointed only he will be present during the counting. If the candidate does not appoint polling agent or counting agent he will be permitted to remain present during the poll process as also the counting himself. If the candidate appoints a polling agent or/and a counting agent he will appoint in the format annexed with this instructions and ensure that its copy be made available to the Electoral Officer, BCA By-Election in his office in Room No. 311 of Hotel Maurya, South Gandhi Maidan, Patna by 2:00 pm on 04.08.2023. He will hand over its second copy to his polling agent/counting agent who will show it to the Presiding Officer before entry into the Polling Station.
3. In BCA Patna By-Election, votes shall be cast through ballot paper. Proxy voting will not be allowed. Ballot papers for the three posts of BCA will be prepared separately. Secrecy shall be maintained while voting. Each voter will be supplied three ballot papers one for each post. Before supplying the ballot papers to the
