
Please find enclosed a Notice for publication for the BCA units and The General Public on your Website and for displaying it on the Notice Board for the general information of the public.



Notice about postponement of By-Elections of the BCA, Patna till further orders


The undersigned has been conducting the By-elections of the Bihar Cricket Association, Patna as per the appointment as Electoral Officer made by Shri Amit Kumar, Secretary, Bihar Cricket Association, Patna after being authorized by their SGM of BCA, Patna dated 04.06.2023 to hold By-Elections for the required posts of the Office Bearers.

In pursuant to that the undersigned started taking necessary action as also initiated the process of By-election and reported to the Inspector General, Prohibition, Excise and Registration Department, Government of Bihar, Patna vide my Memo no. 05/BCA Elec. 2023 dated 15.07.2023 with copies to the District Magistrate, Patna, the Senior Superintendent of Police, Patna and Shri Amit Kumar, Secretary, BCA, Patna for the appointment of an Observer to oversee the work of this By-election.

In the meantime, the By-election process continued as per the published schedule. The Nomination Papers were received on 27.07.2023 and the process of Scrutiny started on 28.07.2023 from 11:00 am.

But, since, the next process of this By-election will need publication of final list of candidates and polling etc., hence, without completing the process of appointing the Observer by the Competent Authorities, the publication of the final list of candidates, polling, counting of polled votes, announcement of result and distribution of certificates cannot be done. Therefore, until and unless an Observer is appointed or any order is received from the Hon'ble Court, the By-elections will remain postponed till further orders issued in this connection by the undersigned.
